Section 6: Accidental Release Measures

Small Spill:

Large Spill:

Poisonous solid. Stop leak if without risk. Do not get water inside container. Do not touch spilled material. Use water spray to reduce vapors. Prevent entry into sewers, basements or confined areas; dike if needed. Call for assistance on disposal. Finish cleaning by spreading water on the contaminated surface and allow to evacuate through the sanitary system. Be careful that the product is not present at a concentration level above TLV. Storage: Keep container tightly closed. Keep container in a cool, well-ventilated area. Do not store above 23°C (73.4°F).

Acute Potential Health Effects: Skin: Acts as a desiccant and may cause irritation with dryness of the skin in cases of severe exposure. Eyes: No adverse effects expected, but dust may cause mechanical irritation. Inhalation: This material is a desiccant and may cause dryness and irritation to mucous membranes and respiratory tract in case of severe exposure. Ingestion: May be harmful if swallowed in large amounts. However, no adverse effects are expected for normal industrial handling. Silicic Acid is a synthetic amorphous silica (non crystalline). Epidemiological studies indicate a low potential for adverse health effects. It is believed to be a nuisance dust.
